Entries in all media, by artists residing in Johnson or surrounding counties will be accepted in the following youth and adult categories:

1. Preschool
2. First and Second grades
3. Third through Fifth grades
4. Sixth through Eighth grades
5. High School
6. Adult Student/Amateur Original Composition
7. Adult Student/Amateur Copy (Your rendition of another artist's work. A photo of the original artist's work must be attached to the back of your work. Your work will be judged on technical ability not originality.)
8. Mixed Media / Textile
9. Adult Professional
10. Amateur Photography
11. Professional Photography
12. 3-D Art
13. Eclipse-Themed Art (All age and levels)

All entries must be delivered, ready to hang, with picture wire (no claw hangers) and properly labeled on the backside upper left corner.

- The size of the artwork should be limited to **no larger than 40" X 40" including frame**. Entries in 3-D artwork should be no larger than 15" X 15" X 15". Artwork larger than these dimensions is subject to approval. Presentation will be considered in the judging.
- **Up to two entries per artist.** (Please make copies of this form for multiple entries.)
- Ribbons, cash prizes and art related gifts will be awarded to the winners.
- **Entries and fees must be delivered to the library on Sat., March 30, 2024 from 10 – 4 p.m.**
- A GGAC committee member will assist in recording your delivery.
- **Make checks payable to the Greater Greenwood Arts Council.**
- Late entries will not be accepted.
- Artwork submitted must be appropriate for a family atmosphere and is subject to approval.

Artwork will hang at the Greenwood Public Library from April 4, 2024 through April 27, 2024. Artists cannot pick up entries early. **Work will be returned to the artists at the Library on Saturday, April 27, 2024 from 12 - 2 p.m.**
